

Annex 2 – Basic Qualification

We hereby solemnly declare that **[BUSINESS NAME OF A LEGAL PERSON/ NAME AND SURNAME OF A NATURAL PERSON + Id. No.]** meets the basic qualification as a contractor

- a) which/who has not been convicted by means of a final decision of any of the following criminal offences in the last 5 years prior to the commencement of the tender procedure, in the country where my registered office is located: criminal offence committed for the benefit of an organised criminal group or a criminal offence of participation in an organised criminal group; criminal offence of human trafficking; criminal offence of fraud, credit fraud, subsidy fraud, receiving stolen goods, receiving stolen goods through negligence, money laundering, money laundering through negligence; criminal offence of misuse of information and position in business relations, negotiating a benefit in awarding a public contract, in a public tender procedure and public auction, collusion in awarding a public contract and in a public tender procedure, collusion in a public auction, damage to the financial interests of the European Union; generally dangerous criminal offences; criminal offences against the Czech Republic, a foreign State or international organization; criminal offences against the exercise of powers of a public authority or officer; criminal offences committed by officers, bribery, other jeopardising of activity of a public authority or a similar criminal offence under the laws of the country where the supplier is established; and with respect to which/whom no conviction for such a criminal offence has been erased from the criminal records. Where a legal person is involved, the above qualification requirement must be met both by the legal person and simultaneously by each member of the contractor's governing body; and where a legal person is a member of the contractor's governing body, the above qualification requirement must be met both by the legal person and by each member of its governing body and by the individual who acts on behalf of the legal person in the contractor's governing body. Where a branch of a foreign legal person participates in the tender procedure, the above qualification requirement must be met by the legal person and the branch head. Where a branch of a Czech legal person participates in the tender procedure, the above qualification requirement must be met the branch head and by the legal person, as well as by each member of its governing body; and where a legal person is a member of the contractor's governing body, the above qualification requirement must be met both by the legal person and by each member of its governing body and by the individual who acts on behalf of the legal person in the contractor's governing body;
- b) which/who has no tax arrears, even with respect to excise duty, recorded in the tax records in the Czech Republic or in the country where it/he is established;
- c) which/who has no arrears in premiums or penalties for public health insurance in the Czech Republic or in the country where it/he is established;
- d) which/who has no arrears in premiums or penalties for social security and contribution to the state employment policy in the Czech Republic or in the country where it/he is established;
- e) which/who is not in the process of liquidation; or subject to an insolvency order issued against it/him or a receivership order issued against it/him under some other legal regulation; or in any similar situation under the laws of the country where the contractor is established.
